Double your gift to St. Vladimir's Seminary at no cost to you.

You'll maximize your impact when you take advantage of your employer's matching gift program.

DID YOU KNOW?

- Every year \$10 billion in corporate matching gifts goes unclaimed
- 65% of Fortune 500 companies offer a matching gift program
- There are 23,000 matching gift programs in the U.S. and Canada
- Two-thirds of American employers surveyed offer matches for payroll deductions

FREQUENTLY ASKED QUESTIONS

Q How do I find out if my employer matches gifts?

A Enter the name of your company in the search bar at svots.edu/support/matching-gifts.

Q What percentage of my gift will my company match? Is there a limit?

A Matching ratios vary, but are typically 1:1. Each company also sets their own upper and lower matching limits.

Q It looks like my company has a matching program—how do I get my gift matched?

A Many companies' matching forms are available at svots.edu/support/matching-gifts. Follow the procedure as described. We don't fill out forms for you, but we'll be happy to assist. If forms aren't available online, ask your HR representative about matching.

Q My company doesn't have a matching gift program. How can I get them to match my gift?

A Talk to your HR Department! Matching is a great way to inspire good will and community participation among employees.

Q What do I need to know about the Seminary to request a matching gift?

A St. Vladimir's is incorporated in the State of New York as a non-profit organization, in accordance with section 501(c)(3) of the Internal Revenue Code of the United States. Please be sure to designate "St. Vladimir's Seminary," EIN: 13-1656625.

Q Where should I send completed forms?

Q I made multiple donations to St. Vladimir's Seminary this year. Can I get them all matched?

A Certainly! Just be sure to note the maximum and minimum amount your employer will match, and the deadline to request a matching gift (both vary by company).

Q I got a "thank you" gift for my donation. Does that affect my matching gift?

A Yes. Employers will match only the tax-deductible portion of your gift (the total amount of donation minus the fair market value of anything you received, such as an event meal).

Q I'm a retiree. Can my company still match?

A It's possible—best to ask. Some companies will match gifts given by spouses as well.
