In order for international students to study at St. Vladimir's Seminary, they must be issued an INS Form I-20 for visa entry into the United States. The I-20 form can only be issued after the seminary has certified that an international student has sufficient funds available to cover all expenses, including travel to and from the United States as well as educational and other expenses.

International students who have been accepted to study at St. Vladimir's and wish to enroll must complete the information below and return the form with the required deposit as calculated in section IV below by **June 15** to: Gabrielle Russin, Student Affairs Administrator, St. Vladimir's Orthodox Theological Seminary, 575 Scarsdale Road, Yonkers, NY 10707. *In the event that the student does not enroll, the seminary will refund the deposit (less the non-refundable enrollment deposit), in accordance with the refund policy as stated online and in the Academic Catalog, with interest at the prevailing U.S. federal funds rate.*
